**INDICATE YOUR MEMBERSHIP CATEGORY**

- Retailers Category**  
Any individual, partnership, association, or corporation engaged in the sale to consumers of hearth, barbecue, or patio related products shall be eligible for membership in the Retailers Category. Additional store locations to receive all mailings, invitations, directory, and listing on the consumer website. **(You receive 5 EXPO Badges)**
  
- Distributors Category**  
Any individual, partnership, association or corporation engaged in the wholesale distribution to dealers or builders or other channels of distribution of hearth, barbecue, or patio related products shall be eligible for membership in the Distributors Category. **(You receive 8 EXPO Badges)**
  
- Associates Category**  
Any individual, partnership, association, or corporation having a commercial interest in hearth, barbecue, or patio related products shall be eligible for membership in the Associates Category. **(You receive 6 EXPO Badges)**
  
- Manufacturer Representative Category**  
Any individual, partnership, association, or corporation engaged in providing independent sales representation for manufacturers of hearth, barbecue, or patio related products shall be eligible for membership in the Manufacturer Representative Category. **(You receive 4 EXPO Badges)**
  
- Service Category**  
Any individual, partnership, association, or corporation engaged in providing mechanical services relating to hearth, barbecue, or patio related products shall be eligible for membership in the Service Category. **(You receive 3 EXPO Badges)**
  
- Non-Profit Category**  
Any individual, partnership, association, or corporation having a non-profit, non-commercial interest in hearth, barbecue, or patio related products shall be eligible for membership in the Non-Profit Category. **(You receive 3 EXPO Badges)**
  
- Dual Affiliate Membership Category**  
For those whose primary membership is in another affiliate but wish to receive all mailings, invitations, and regional directory. **(No EXPO Badges available for this category)**
