HPBA MEMBERSHIP CATEGORY QUALIFICATIONS AND DESCRIPTIONS

Any individual, partnership, association or corporation eligible for membership in more than one category must become a member of the association in that category which represents the primary business of the member or in the higher dues paying category.

Non-Manufacturer Membership Category Descriptions

Retailers Category

Companies in the business of sale to consumers of hearth, patio or barbecue related products.

Distributors Category

Companies or individuals in the business of wholesale distribution to dealers or builders or other channels of distribution of hearth, patio or barbecue related products.

Installing Distributor

Companies that buy hearth, patio and barbecue products directly from manufactures then sell, install and service those products for residential and commercial builders.

Manufacturer Representative Category

Companies or individuals in the business of providing independent sales representation for manufacturers of hearth, patio or barbecue related products.

Service Category

Chimney sweeps, installers, and companies in the business of providing mechanical services relating to hearth, patio or barbecue related.

Associates Category

Companies having a commercial interest in hearth, patio or barbecue related products.

Non-Profit Category

Companies or individuals having a non-profit, non-commercial interest in hearth, patio or barbecue related products.

For U.S. federal income tax purposes membership dues may be deductible as business expenses, not as charitable contributions.
